Decisions about whether the conditions referred to in Articles 13 and 14 of the Rules on training and financing young researchers in research organisations (Official Gazette of the Republic of Slovenia, No. 24/06) are met shall be made by the Agency:

- \rightarrow that the conditions for the head of basic or applied research project are met,
- → that he/she actively participates in a research programme or at least one research and development project,
- \rightarrow that he/she is employed in the research organisation,
- \rightarrow that he/she trains less than three young researchers at one time,

Account will be taken of the following: young researchers under financing and in suspension status as well as all those whose contractual term has expired and they have not yet successfully concluded their training programme – the latter shall be recognised in a period of two years after expiration of the contractual term, excluding the case in which the funds were repaid due to non-completed programme.

This condition must be met by the 2006 mentor candidates as at the day of opening the tenders for the public call, and by the mentors to be included in the 2007 mentor list prior to signing the contract on financing and training а young researcher. In determining a mentor candidate's quota of 3 young researchers, account will not be taken of those young researchers who are being trained by him/her for the economic sector (both mentor and young researchers were approved at a public call of the Ministry of Higher Education, Science and Technology).

→ that in the preceding year no young researcher was allocated to him/her for training (if the young researcher terminated the contract in the period of 6 months following its conclusion, the mentor can again apply at the public call in the next year).
